How can I respond?

Every member of Christ Church is asked to respond to our mission to

MAKE PASSIONATE DISCIPLES FOR CHRIST

by reviewing the commitment to God's service that we make each year in the area of Financial Giving.

Why give?

Giving is a response to God's overflowing generosity to us.

All that we have comes from him and we give back to him the **first fruits** of what we have. (Malachi 3: 6-10, Luke 21: 1-4 and 2 Cor 9: 6-15)



- It is an act of praise and worship and an expression of our gratitude
- It enables God's church to expand our mission, witness, and worship.
- It is a spiritual discipline that is good for our souls and part of growth as a disciple of Christ.

What should we give?

God gives to us out of his abundant and outrageous love for us. The bible urges us to give what we can and to **consider making a joyful sacrifice**. What we give is to be **used for God's glory** and to further the kingdom.

We would love to **move from deficit to abundance**.

The choice is yours. Ask God for guidance.



How should we give?

In 1 Corinthians 16, Paul tells us to give:

- *Regularly*—**at set times**
- *Individually*—**everyone is invited to participate**
- *Systematically*—**let giving be thoughtfully planned**
- *Proportionately*—**according to our means**
- *Locally*—**our primary commitment is through the local church**

Running costs	10%
Building	15%
